- Reduction of direct costs to traders
- Reduction of time required for customs procedures



Customs Administration of Republic of Macedonia

Reduction of direct costs to traders

- Processing customs declarations fee – abolished
- Customs escort fees – abolished
- Vehicle weighting fee – abolished
- Public customs owned terminal fee significantly reduced



Reduction of time required for customs procedures

- New National Customs Declaration Processing System in Development
- Electronic Single Window for import, export and transit licensing and tariff quota
- Simplified Procedures & Customs Clearance at Border Crossings
- Advisory Body for Customs Cooperation Formed

Reduction of time required for customs procedures

- Mobile X-Ray Scanners for inspection of large vehicles and containers operational
- Centralized Video Surveillance System introduced
- Automatic Number Plate Recognition System Introduced

Electronic Single Window

Services Provided

- **Single frame for all required information for obtaining import, export or transit of 66 licenses**
- **Submission of requests and tracking the current status of licenses from their own premises**
- **Equal legal validity of electronic and paper application**
- **Issuance of electronic licenses and monitoring their use**
- **Free of charge**
- **Services available 24 hours/ 7 days a week**
- **Saving time and costs for businesses as a result of electronic submission of applications**

4 Mobile X-Ray Scanners for inspection of large vehicles and containers operational

- non-intrusive inspection

Simplified Procedures & Customs Clearance at Border Crossings

- Promotion of facility given by Simplified Customs procedures
- 24 hour clearance at the Border Crossings which have suitable infrastructure enabled:
 - No need of a transit declaration, therefore no expenses for it;
 - No double payment of administrative taxes;
 - No need of double stay at terminals, therefore no expenses for terminal services,
 - Increased capacity for business cycle planning



Second Phase of Regulatory Guillotine

- additional facilitation of import, export and transit by providing continuous presence of the relevant inspection services at all Border Crossing points
- reduction of the amount of documentation, fees, elimination of the unnecessary procedures
- electronic connection with the other competent agencies
- Risk analysis and selectivity introduced to another agencies
